PURPOSE & SCOPE

*This internal specification (IS) authorizes the use of new or replacement specifications in place of obsolete, discontinued, or superseded specifications.

Authorizations can be divided into two categories:

- 1) Group 1: Replacement specifications for which the controlling agency has designated an exact replacement, and the replacement is noted on the cancellation notice for the obsolete/cancelled document. The new document then becomes a “superseding” document and shall be authorized for use without being referenced on this internal specification or on the L-3 Communications, Communication Systems-West (CSW) next higher assembly. This substitution is universally acceptable across CSW, in compliance with the Policy Statement contained herein.
- 2) Group 2: Specifications which are cancelled without replacement, or for which the obsolete/cancelled specification’s cancellation notice suggests multiple options, which may be considered. In such a case, the new specification must then be selected by CSW Engineering, in consultation with CSW Component Engineering. Once the new specification has been researched and approved, it shall then be listed in Table 1 of this document. This substitution is universally acceptable across CSW, in compliance with the Policy Statement contained herein.

Note that this document is to be used when modifying existing CSW engineering drawings and bills of material and associated documents. New drawings must reflect the replacement or new specification and not the obsolete or cancelled specification. Existing drawings should only be updated to reflect the new specifications if other changes to the drawing are required.

POLICY STATEMENT

When using existing released drawings that call out obsolete or discontinued documents, the replacement document shall be used as a direct replacement, unless contractually obligated. The department responsible for the replaced document should **make certain that** the status of the obsolete or **cancelled** document **is** changed from “Active” to “**Restricted - No Longer in Production**” or other appropriate **Teamcenter Secondary Status**.
